Payor shall be notified in writing, together with proof satisfactory to Payor, of any change in ownership, decimal interest, or payment address. Payor is not bound to recognize any change in ownership affecting payments for gas sold during any calendar month, until all necessary paperwork has been received and processed. It is understood that any vendee or assignee of said wells or the production thereof shall be subject to the terms hereof. The undersigned severally agrees to indemnify Payor against any loss resulting from Payor having made payments in accordance with this Division Order and prior to receipt of written notice of a transfer of such interests, and the proof satisfactory to Payor of the transfer or change. If three or more parties become entitled to the above referenced interest after execution of this Division Order, Unit Operator may withhold payment thereof without incurring an obligation to pay interest, unless and until furnished with a recordable instrument executed by all parties designating an agent or trustee to receive payment for all. All such changes shall be effective the first day of the month following receipt of proper notice unless an effective date is specified in documents.

Payor is authorized to withhold payment without interest, pending resolution of a title dispute or adverse claim asserted regarding all or a portion of the interest in production claimed herein by the undersigned. The undersigned agrees to indemnify and reimburse Payor any amount attributable to an interest to which the undersigned is not entitled.

Payor may accrue proceeds until the total net amount exceeds Fifty Dollars (\$50.00). In any event, all accumulated proceeds shall be tendered in October of each year. A specific itemized explanation of all post-production costs (PPC's) to be assessed and an annual accounting of gas sales and deductions after the end of the 12-month accounting period is available to a Royalty Owner who is charged for any portion of PPC's. A written request for this information may be sent to the address shown on your revenue check.

This Division Order does not amend any lease or operating agreement between the undersigned and the lessee or operator, or any other contracts for the purchase of oil (including condensate) or gas. In addition to the terms and conditions of this Division Order, the undersigned and Payor may have certain statutory rights under the laws of the state in which the property is located. This Division Order shall be binding upon and inure to the benefit of the heirs, successors in interest, legal representatives and assigns of the undersigned.
